## Methods Used to Determine Amount and Recipients of Emergency Financial Aid Grants

Based on CRRSAA HEERF II provision requirements, the institution developed a system of awarding a larger amount of emergency grant to students with greater need. The institution developed 3 tiers of need: high need, medium need, and low need.

Students were categorized via the EFC on the FAFSA previously submitted to the institution. Students who did not submit a FAFSA were still disbursed grant funds and were categorized as "low need if not exceeding an income threshold."

# Instructions, Directions, or Guidance Provided by the Institution to Students Concerning Emergency Financial Aid Grants

As the Department of Education did not stipulate any disclosure requirements under the CRRSAA HEERF II Emergency grants, students received no disclosure with their emergency grant funds.
